Purpose: To provide instructions for installation of an upgraded 0789-03-307-1 Dual Tachometer

Eligible Serial Numbers: All. The intent of this TB has been incorporated by Eagle Copters at 407HP #018 and subsequent prior to delivery

Compliance: Eagle Copters will be working with operators to incorporate this upgrade into all 407 aircraft that have been modified per SH14-47/SR03496NY

## Description:

In October 2017, a 407HP experienced an uncommanded engine shutdown in flight. While the root cause is believed to be related to the Frangible Fuse in the engine, the investigation has revealed that additional annunciation of Frangible Fuse faults will be beneficial to operators. Therefore, P/N 0789-03-307-1 Dual Tachometer has been updated to illuminate the FADEC MAINT advisory light, in flight, if a Frangible Fuse fault is annunciated by the FADEC.

- Replace the 0789-03-307-1 Dual Tachometer Rev. A or previous with a 0789-03-307-1 1. Dual Tachometer Rev. B or later per ICA-E407-789 Section 95.5.6.
- Ensure that the latest version of the GSE software is being used to interogate the 0789-2. 03-307-1 Dual Tachometer. Version 1.3.4.0 Rev. C or later is required. Download new software at http://www.diamondjinc.net/support/Diamond J Indicator Interface.zip
- 3. Ensure that FMS-E407-789-1 Rev. 2 has been inserted into the Rotorcraft Flight Manual
- 4. Ensure that ICA-E407-789 Rev. 3 is being used to perform maintenance on the helicopter
- 5. In the event of FADEC MAINT advisory light illumination in flight, the procedures in FMS-E407-789-1 and ICA-E407-789 must be followed
- Per Honeywell SB HTS900-77-10-0008, P/N 4-301-549-03 Frangible Fuses that exhibit 6. Frangible Fuse Link faults must be removed from service
- Make entry in aircraft technical records indicating that TB-E407-789-12 has been complied 7. with
- 8. Complete and return Sheet 3 of this TB to Eagle Copters to indicate compliance

## Weight and Balance:

The incorporation of this TB has a negligible effect on the aircraft weight and balance
