- Install the NVIS compatible IBF annunciator, P/N LED-40-17-KB-E2A54, IAW Section 2. 3.17 of 1003-MI-001.
- 3. Make entry in aircraft technical records indicating that TB-E407-789-18 has been complied with.
- 4. Complete and return Sheet 3 of this TB to Eagle Copters to indicate compliance.
